My career in banking began near the end of my senior year in high school, when I worked and attended school at night. I undertook various roles within Retail and Loan Operations before transferring to Sales, holding progressively responsible positions throughout my career in Business Banking, Commercial Lending, Community Development and most recently, Public Finance. I was a lead analyst on the early mitigation of an FDIC Cease & Desist order at Pan American Bank, selected to participate in a Loan Process Steering Committee and rollout of LaserPro and a Credit Scoring Module at Banco Popular, and actively participated in the implementation of Hispanic initiatives at Banco Popular, Harris Bank/BMO, and PNC.

Currently, I lead the regional provision of traditional banking services and capital market underwriting and distribution capabilities to large public sector entities for PNC Bank. In 2022, with the largest Illinois county facing an unprecedented delay in the issuance of second installment tax bills, Cook County's finance leadership and PNC collaborated to create a \$500 million, zero-interest loan pool with tax intercept. We completed the rollout of the program within five weeks and it made millions of dollars of zero-interest loans available to local governments and taxing bodies like municipalities, park districts, libraries and schools.

Following my appointment in February 2022 as Board Chair of the Illinois Tollway, my primary responsibility was to ensure the board delivered policy direction and oversight for the agency while facilitating effective collaboration between the board and the Tollway's leadership team. Concurrently, as CEO of the Illinois Tollway, my responsibilities encompassed oversight of the agency's 14-year, \$15 billion-plus capital plan and establishing a leadership structure that aligned the agency's core operational components into district pillars.

While serving on the board of Chicago Community Loan Fund (CCLF), I was part of the Strategic Planning Committee in 2015 and 2020, working to determine the trajectory and level of growth for the organization's loan program. In 2015, the Committee assigned a stretch goal of growing CCLF's loan portfolio by \$50 million. After meeting that goal by fiscal year-end 2019, the committee assigned a new goal of doubling the loan portfolio to \$200 million—doubling the size of the loan pool in five years what took the organization 30 years to achieve by 2019.

I strongly believe in setting an expectation for interaction based on honesty, transparency, and integrity, and will bring these assets to a corporate board position. My default is transformational leadership, rooted in taking time to know one's team and creating an environment that leverages the team's experiences and knowledge to encourage innovation and growth. The trust established by understanding one another and the autonomy given to allow others to lead and benefit from their successes, creates an environment that is difficult to dismantle and, more often than not, produces exceptional outcomes.

A culmination of this work is Northwestern Medicine's new Bronzeville outpatient facility, which will serve approximately 50,000 patients per year, and will become a staple in the community where we can learn, gather and grow to improve health equity across the Chicago area.

My understanding of medicine, healthcare operations and community relationships will bring a unique voice to a corporate board. Thoroughly evaluating a company's strategic decisions, operational processes, and market dynamics can help assess potential risks and the potential impact to the organization.

This work must be done using different perspectives, considering all facets and parties and how the outcome could be interpreted. It is important to inspire and empower others thus fostering collaboration and a sense of purpose – this is my leadership philosophy. Leadership can assume they know the desires of their staff or those they serve but to be truly effective, leadership must partner and learn with their team and their customers in a manner that is open, honest and straightforward. We cannot be effective teachers without being exceptional listeners and knowing how to build trust.
